Within 30 days of your successful election to the Rideau Club, an invoice detailing the entrance fees and membership dues and levies, prorated to the end of the calendar year will be provided via email or mail.

All fees, dues and levies are subject to HST.

Accepted methods of payment include cheque, credit card (Visa or Mastercard), e-transfer or direct deposit.

Annual membership dues are assessed each year and can be applied monthly, quarterly, semi-annually or annually. For the first year of active membership, new members will be assessed their annual dues on a monthly basis. Members have the option to change their payment schedule each January.

Levies and special assessments are assessed each year and applied to member accounts on a monthly basis.

House minimums are assessed each year and applied to member accounts on a semi-annual basis (July and December). The amount by which the minimum house account fee exceeds the aggregate of the actual expenditures of the member for food and beverage services of the club during the period will be charged.

Account statements are issued on or near the 1st of each month via the communication method indicated in Section Six. Payments are due on the 15th of each month.

At this time, The Rideau Club is able to keep one credit card per account or sub account* on file for pre-authorized payments, and all charges incurred within a month will be settled to that credit card the following month. By default, dining charges will be applied to your house account, however these charges can also be paid by cash, credit or debit at the time of purchase. If you wish to pay any charges on your house account by another means, you must notify the accounting@rideauclub.ca immediately.

*If a member has established a personal, spousal and/or business account, they may place a credit card on file for each. Members have the option to make a payment online, via e-transfer or direct deposit at any time should they choose to not have a credit card on file.
